INTRODUCTION

Full Professor of Cultural Anthropology (s.s.d. M-DEA/01) at the Department of CPS, he is co-director of the "Luigi Bobbio" Centre for Public and Applied Social Research. He teaches *Culture and power* and *Cultural anthropology*. He created and currently directs the "Archipelago Europe" Research Center, which cooperates with the OCTA (Overseas Countries and Territories Association). He is a member of the Commission for the National Scientific Qualification for Associate and Full Professors of Cultural Anthropology. He was Vice Director for Research (2015-2019) of the Department of CPS, auditor member of the Research Committee of the Academic Senate of the University of Turin; he has chaired the Degree Course in Cultural Anthropology and Ethnology (2013-2015). He was Chairman of the Ariodante Fabretti Foundation in Turin (2013-2019). A specialist in Pacific Island Studies, he has carried out over 24 months of fieldwork in different European overseas areas and societies (Futuna and Wallis, New Caledonia, Reunion, French Guiana), and was Visiting Professor at the Université de la Nouvelle-Calédonie and the Université de La Réunion. His main areas of study are political anthropology, anthropology of the body and anthropology of heritage. He is actively engaged in the dissemination of scientific and anthropological knowledge: co-chair of the scientific programme of the "Dialoghi sull'Uomo" Festival in Pistoia (<https://www.dialoghisulluomo.it>), he has written over 80 anthropological articles for "La Lettura"-Corriere della Sera newspaper and has been a guest at festivals and on radio and television. He has collaborated with the Treccani Institute for the Italian Encyclopaedia.
